Why RJ Strength Based Repairs Work Best

RJ interventions attempt to foster growth and reintegration into the community.

Because youth are still forming their identities and developing socially and cognitively, they are more responsive to interventions that encourage the development of their personal prosocial identities.



#### What Makes It Restorative?

- A preservice orientation on the restorative approach for both the youth and the community member in charge.
- 2. An opportunity for the youth to learn the value behind contributing and to feel more connected to their community.
- 3. Engaging in meaningful (nonmenial) service projects that provides tangible benefits to the community.
- 4. As much as possible, connecting the repair to the harm done while considering the youth's skills and preferences.
- 5. The repair is proportional to the harm done.
- 6. Community members interact with the youth on a personal level while performing the same work as the youth.

# RJ Repairs deliver:



- 1. Meaningful work.
- 2. (Increased Self-efficacy
- 3. Community Connectedness



### THE BEST APOLOGY IS CHANGED BEHAVIOR

- Write a letter detailing all the harm caused, taking full responsibility for the actions and how things will be done better in the future. (to the SRO, Principal, Neighbor, Parent, etc.)
- Volunteer for a cause that was important to the person who was wronged, and making efforts to make a difference in that community.
- Using creative talents such as art, writing, music or performance to create a gift for someone that was harmed.



## Repairing Emotional Harm as a Restorative Repair

- 1. Acknowledge the harm done.
- 2. Reflect on your behavior. Understand your own motives.
- 3. Offer a sincere apology.
- 4. Validate their emotions by actively listening and understanding their perspective without becoming defensive.
- 5. Be specific about your mistake.
- 6. Make amends if possible.
- 7. Give them space.
- 8. Learn and grow.
- 9. Rebuild trust. This takes time and consistency.



Put yourself in their shoes. What would they want? What do they need?

Words hold immense power.
 They can build bridges or tear them down, heal wounds or inflict pain.

### Trust-Building Ideas that Understand Trust is Fragile

- Apologize for violating their trust, without expecting anything in return.
- The words used are less important than speaking from the heart.
- 3. Ask what can be done to regain their trust. Give them time to think about an answer.





- 4. Spend time with family to rebuild trust with them.
- 5. Demonstrate responsible actions. Do chores. Keep promises. Follow the rules. Tell the truth.
- 6. Demonstrate through caring actions. Acts of kindness.
- 7. Controling emotions. Showing respect.

# AMEND-MAKING ACTIVITIES

#### **DEVELOPS EMPATHY**

Youth attitudes towards themselves and others are likely to change as a result of demonstrating competence, value and reliability duirng meaning ful service projects.





ACCOUNTABILITY

These types of activities may provide youth with evidence that they can control their maladaptive behaviors in other environments, such as school.

These activities provide opportunities to develop self-control and self-efficacy as they require more focus.

### Serving on a Teen Court Jury as a Restorative Repair

- Most Teen Courts in NC include:
  - Community Service
    - Hours
  - Peer Jury Duty
  - School Attendance
    - & Grades

- Other Repairs that are often included:
  - Training Classes
  - Written or Verbal
    - **Apologies**
    - **Restorative Projects**

Being a Peer Circle Volunteer as a Restorative Repair

- Peer Accountability Circles &
- Responsive Circles both utilize peer processes
  - As volunteers
  - As youth in the program to pay it forward



## Mentoring Others as a Restorative Repair

Have a youth who is struggling to understand "differences" work in the special education classroom.



Assign an experienced juror from Teen Court to mentor a new juror.

Assign a youth who has been doing community service for awhile to mentor a youth just coming on.
